A friendly reminder to all leaseholders, their families and guests, that illegal fireworks will not be tolerated in Salishan. As a reminder, **No Fireworks of any kind are allowed on Oregon State Beaches or Salishan Leaseholders Property.** This includes driveways and streets. However, legal fireworks may be used on the bayside of the sand spit, just beyond the parking lot at the north end of Salishan Drive. We ask that you clean up all of your debris and leave it at the parking lot. Please work with SLI management to ensure a safe and fire free 4th of July holiday.

The city of Lincoln City provides additional security for the fireworks show. They will have two city employees and a TCB Security crew working to maintain the safety and security of all people attending and putting on the fireworks show.

OPEN BEACH ACCESS':

- ❖ Access #1: 143-145 Salishan Drive; use caution, steep in areas. Mainly used by neighboring leaseholders and walkers as there is no delegated parking and this access is steep in places.
- ❖ Access #2: 163-165 Salishan Drive is in great condition, easy to access, parking, flat rock steps.
- ❖ Access #3: Sea Dunes, across from the Community Center is in great condition, easy to access, parking at Community Center.
- ❖ Access #8: 281-283 Salishan Drive **will be opened Saturday, July 2nd**. Thanks to Kauffman Excavating. This access is used by neighboring leaseholders and walkers as there is no delegated parking. There's the option to park at the four-way stop and walk north to the access.
- ❖ Access #11: 347-349 Salishan Drive is in great condition, easy to access and very smooth for easy walking. Mainly used by neighboring leaseholders and walkers as there is no delegated parking.
- ❖ The end of the spit continues to be one of the best options for beach access and has multiple ways to get on the beach including good parking options.
- ❖ The remaining Beach Access' are not accessible and are closed until further notice.
